## VT Statewide Parcel Mapping Project

The Statewide parcel mapping project has begun to pick up speed with towns beginning work with their designated mappers. The main objective of the project seems to be to get towns up to date with their towns parcel data. This project aims to get a 99% match rate, matching parcel GIS data with the Grand List. This additional information will be used to make the current ANR Atlas and E911 Viewer more accurate and the information that resides in your town better as well. This project is currently volunteer, with towns signing up on what appears to be a first come basis. The town's that sign up will not be required to budget any additional funds as are available to cover updates and standardization. This may be an appropriate time to work in a new tax

map update with the new data if any changes to the parcel map are made during this process. Funding of this statewide project does not include updates to your tax maps this could be included in your current towns budget or additional recourses may be needed to cover this expense. These details should be reviewed by the Listers and other town offices to see what would be in your towns best interest. Currently there are 3 phases to the mapping project listed as follows.

#### PHASE 1:

Has begun, companies are currently in the process of being assigned towns throughout the state. Towns should be looking at beginning work with selected mapping right now.

#### PHASE 2:

If you are currently not in phase 1 towns should be looking to sign-up for phase 2. The best way to get started is to email Leslie Pelch (Outreach Coordinator leslie.*pelch*@vermont) to indicate that you are interested. The email should contain the following information about your maps 1) Date (year maps were last updated) 2) Format (what does your town currently have GIS data, Hand drawn maps, or Digital maps) 3) Mapping Company (if you are currently working with a mapping company please identify who they are).

#### PHASE 3

Is projected to start in 2019 with details becoming finalized.


#### SUMMER 2018
